Dear Sir,

On 2 June 1981 you wrote to Colin Walters about a request by The Observer that a Mr Solomon Steckoll should see someone about certain allegations of his which were to be published in The Observer later that month.

We agreed to field Mr Steckoll and I duly saw him to find out what the nature of his allegations was. As a result, certain researches are afoot in the Ministry of Defence.

However, in addition to the Ministry of Defence's problems Mr Steckoll raised one particular issue about the award of a Knighthood to Sir Victor Carey the wartime Bailiff of Guernsey. He contended he had been refused permission by No.10 to see related papers on this award and believed from other evidence (which he said was then in Jerusalem) that there might have been a cover up on this point. Mr Steckoll has now returned from Israel and is once more asking to see the honours file on Sir Victor Carey. We do not feel we would be justified in allowing this and I have just written to Mr Steckoll to tell him so. I attach a copy of my letter for your records in case he should try to gain access by a roundabout route.

I am writing further to our recent telephone conversations. As you know, the allegations you have advanced concerning events occurring during the German occupation of the Channel Islands are still under consideration within Whitehall. We shall be letting you have a reply in due course when these investigations have been completed.

There is, however, one matter which I am able to deal with straight away, as it is for the Home Office. You asked me whether, if necessary with an undertaking on your part not to divulge or to make any public use of the information, you might have sight, or perhaps a photocopy, of our relevant papers concerning the award of a Knighthood for his services under the occupation to Victor Carey, Bailiff of Guernsey.

We have, as I undertook we would, carefully considered your request, but I must now tell you that our decision is that we should not be justified in departing from the normal rules regarding the confidentiality of these papers, which are to remain closed to the public for some considerable time yet.

MR SOLOMON STECKOLL - OBSERVER ARTICLE ON GERMAN OCCUPATION OF ALDERNEY

1. I saw Mr Steckoll, in company with Miss Ward, Lt. Col Taylor, Mr Gurney, Mr Harding and Mr Percival from MOD, Mr Wood PRB, and Mr Wilson E2, on Thursday 4 June in Queen Anne's Gate, as we agreed.
2. I told Mr Steckoll that my purpose was to afford him the opportunity he had sought to give the Prime Minister the courtesy of advance warning of the allegations he would make in the article to appear in the Sunday Observer of 7 June, serialising his forthcoming book "The Alderney Death Camp" to be published this summer by Granada. I said further that the venue of the Home Office had been chosen merely because it was the Department currently looking after Channel Island affairs on behalf of Her Majesty's Government and that I would not be in a position to do more than to undertake to listen to what he had to say and to see that his points would be properly considered.
3. Mr Steckoll concentrated on three cases in particular - two military, one civilian.
4. The first concerned Major Karl Hoffman who had left Alderney in 1943 for Jersey where he became Kommandant. Mr Steckoll alleged that British Authorities had let it be known that Hoffman, after spending the years up to 1948 in a POW camp, had then been handed over to the Russians and hanged as a war criminal in Kiev in front of 40,000 people. Yet, claimed Mr Steckoll, he had traced a Karl Hoffman (whose German army number matched that of the man supposedly hanged) who did not die until 1974 in Hameln (Hamelin) in the FRG. The implication is clear - the British authorities had allowed a war criminal to escape punishment, while putting out a version of events which would allay the suspicions of anybody who might wish to see Hoffman tried for war crimes (there are grounds for believing that here Steckoll is badly mistaken - that he has confused Major Hoffman (a regular army officer) with Johannes Hoffman of the 'Organisation Todt' which was responsible for camp and fortification construction and the subsequent maltreatment and death of many thousands of slave labourers. MOD say that the file on this Hoffman is marked "handed to Russians" - his actual fate is, as yet, unknown/unclear.
5. The second concerns KORVETTEN - KAPITAN MASSMANN. In July 1944, in his role as harbour master at Alderney he is said to have prevented, at pistol point, the rescue by German sailors of the five surviving crew of a Lancaster bomber which had ditched. All five RAF personnel died. It is alleged that, Massmann was told by his military interrogator after the war that "we have not quite got enough to hang you" or words very much to that effect. No mention was made of his subsequent fate.
6. The third case involves Victor Gosling Carey, Bailiff of Guernsey in locus of the Lt. Governor; Mr Carey was knighted in December 1945 for his services under the occupation. Mr Steckoll revived the charge of collaboration against Mr Carey in that he caused to be printed and put his name to a notice in the "Star" newspaper of July 1941 offering

a £25 reward for the conviction of anybody chalking up a V for victory sign. The MI19 file (no 2503) sums up the Islanders feeling of this action as being "unnecessary and gratuitous" since the Germans were already making strenuous efforts in this direction.

7. Mr Steckoll made three requests: a. that he might have sight of the honours file in respect of Sir Victor Carey's knighthood. Added that he had asked the Prime Minister's office for this some six months ago but had been "turned down"; and that this file was not available in the Public Record Office. b. Whether the Prime Minister of the day (Mr Attlee) had seen the MI19 file on alleged collaboration with the Germans on the part of Sir Victor Carey while acting as Lieutenant Governor during the occupation. c. For clarification of the Agreement made between the United Kingdom and the Federal Republic of Germany in 1959 on the exhumation from Alderney and the reinterment in a German War Cemetery in France of 384 bodies of persons who had died on Alderney during the occupation. The object of this being eventually to obtain permission for the bodies to be reclassified as German.

8. Mr Steckoll handed over several photocopies of mainly MOD documents allegedly substantiating his case; these I gave to the MOD representatives, on the understanding that they should be returned to me to send back to Mr Steckoll's literary agents. Mr Steckoll also referred to some 300 other documents, some of which I understand to have originated in the Islands during the occupation, but which were in the keeping of his literary agent. Mr Steckoll agreed that our investigators could have sight of these latter documents on the understanding that they would be returned to his literary agent. Lt Col Taylor said that he would arrange for this to be done. Mr Steckoll's literary agent is Mr J Simmons, 159 Pavilion Road, Knightsbridge, London SW1; telephone 235 5110 (office) / 5732 (home).

9. I undertook to inform Mr Steckoll whether or not he could see the file referred to at a. above, by telephone, to the Observer Newsdesk (236 0202) by noon tomorrow, Friday 5 June. I, of course, made no comment at this request.

10. Finally, I asked for Mr Steckoll's address in Israel in case there should be a need to write to him on these matters: Mr S Steckoll, 9 Shachewitz Street, Gedera, Israel 70700.

11. Mr Steckoll left after some 40 minutes, saying as he left that he had made a complimentary remark in his article that the authorities in the United Kingdom had been entirely open with him, in contrast with the treatment he had received from those in other countries.

12. The following press line, prepared by Home Office PRB for use on an 'if asked' basis, has been read to and cleared by No.10 Press Office (Liz Drummond) and MOD Press Office (Alan Percival).

"Mr Solomon Steckoll today (Thursday 4 June) met at his request, Home Office and MOD officials.

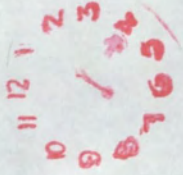
The meeting provided Mr Steckoll with an opportunity to outline some of the allegations appearing in the excerpts of his forthcoming book in the 'Observer'.

I enclose a copy of a letter from the 'Observer', which I have discussed with you and with Colin Walters at the Home Office in the course of the day.

I realise that it will not be easy to locate papers dealing with the matters in question. Nevertheless, I am sure it is necessary for the Government to be able to offer some response. We cannot simply stand on our difficulty in tracing the papers. It seems most likely that the report by Brigadier Snow will belong amongst your records. I wonder whether Mr. Steckoll's claims that there is no trace of the report simply refers to the fact that it is not available in the Public Records Office.

I should be grateful if the Cabinet Office could see whether they can throw any light on these matters from their records. I should also be grateful if you could make some further check about Brigadier Snow's report.

I thought I had better let you have a note of my conversations with Mr. Steckoll, who rang up first on 12 September asking if it would be possible for him to come in and talk to Honours Section and to see the correspondence between No. 10 and the Palace relating to Mr. Carey's knighthood in 1945. At that time he said only that he was doing some research and that the Public Records Office did not contain this material.

I spoke to Daphne Edmunds who helpfully gave me the date on which the announcement was made in the London Gazette and the text of the citation. She said that further details, such as correspondence with the Palace, were strictly confidential and personal and would not be sent to the Public Records Office. (The knighthood of Victor Goslyn Carey, aged 74, was announced on 11 December, 1945, when he was Bailiff and Acting Lieutenant-Governor of Guernsey.)

I gave this information to Mr. Steckoll who then told me why he was asking. He is writing a book (publication mid-1981) which will also, he says, be serialised in The Observer, dealing with a secret SS concentration death camp on the island of Alderney.

He claims to have copies of three documents:

1. From the Jerusalem archives, a paper saying that Carey, in his position as war-time leader of occupied Guernsey, collaborated in persecuting Jews in the Channel Islands.
2. From MI 19, a paper describing him as a collaborator with the Nazis.

/3. From FCO,

3. From FCO, a paper giving a description of his activities and taking a jaundiced view of his fraternising with the German occupying forces.

He says that what he is trying to establish was whether Mr. Attlee knew of these allegations when he recommended Carey for a knighthood; if Attlee did not know, why was he not told - did the Civil Service cover up, and if so, who and why?

Stockoll is now out of the country and will return in mid-October; through his literary agent, a Mr. Harrison, I have asked him to write to us setting out the information he seeks. It is doubtful whether Stockoll got the message as he left no forwarding address or number with Mr. Harrison who describes him as 'a most unusual man and not a full-time writer'.

I have no idea what part, if any, of this is true (my sheltered youth has not exposed me to even a rumour of a concentration camp in the Channel Isles); Stockoll clearly thinks he is on to something and, whether or not he writes to us, we will need some sort of line to give him when he gets in contact again in mid-October.

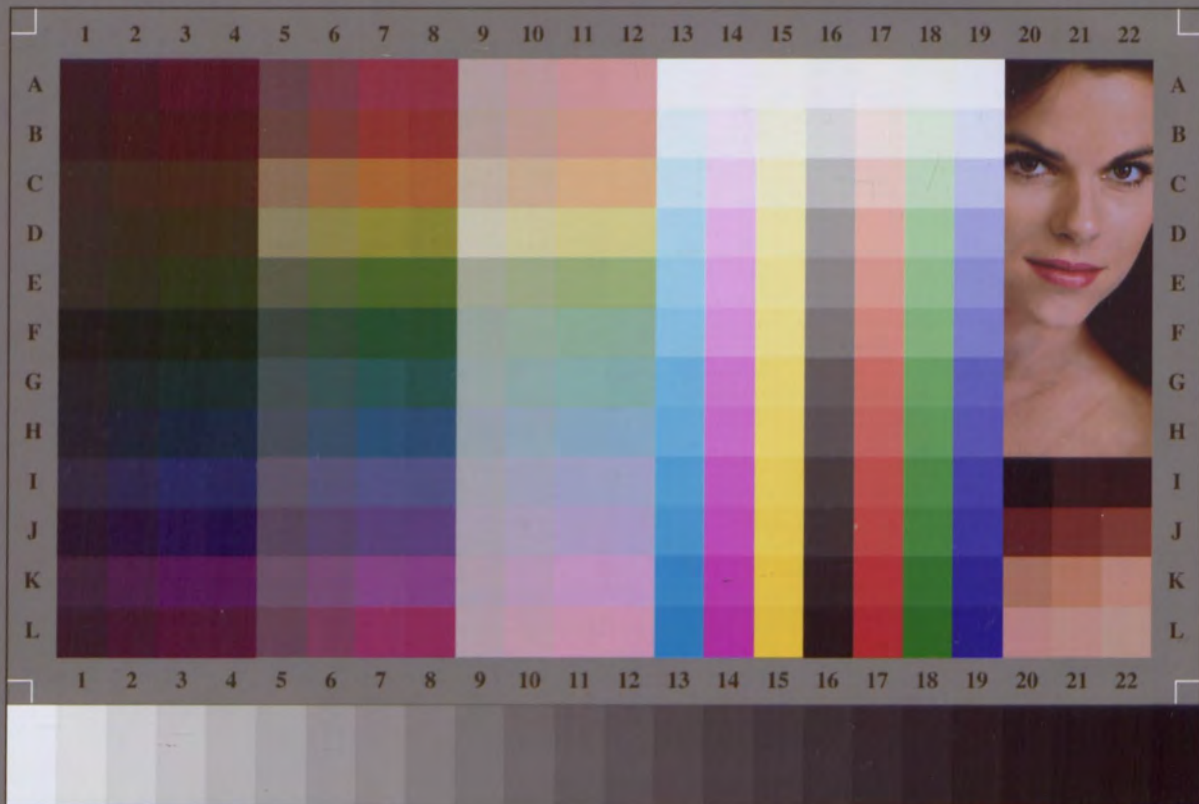
