EUROPEAN COUNCIL 27-28 OCTOBER 1990

A further attempt is to be made to break the deadlock over agreeing a Community position on agriculture for the GATT negotiations, with a joint meeting of Agriculture and Trade Ministers in Luxembourg on Friday. If agreement is reached there, the subject should not need to be discussed substantively at the European Council. It is possible, however, and on current indications quite likely, that agreement will not be reached on Friday. We know it is the Foreign Secretary's view that in these circumstances the issue should pass to the European Council for substantive discussion.

Arrangements will of course be made by the FCO for telegram reports to be passed from Luxembourg to Rome overnight on Friday. But my Minister's firm view is that it could prove necessary to have an official who has been following the agriculture negotiations available in Rome, both to brief the Prime Minister if detailed discussion develops in the European Council itself and to cover any working group which may be set up in the margins, for instance to consider some new compromise text. This would be likely to relate to 'accompanying measures' to support farmers' incomes designed to meet the demands of the Germans and others, and go beyond the terms of the proposal already on the table.

I am therefore writing to ask you to add to the list of officials in our party that of Mr Richard Packer, Deputy Secretary in this Department, who will be in Luxembourg on Friday and will travel

on to Rome if that turns out to be necessary. I should be glad if the Italian authorities could be informed of this addition to the list too.



SUMMARY

1. PRESIDENT MITTERRAND WELCOMES CHANCE OF BILATERAL WITH THE PRIME MINISTER.

DETAIL

2. HENNEKINNE TELEPHONED ME THIS MORNING TO SAY, WITH SOME EMBARRASSMENT AT THE DELAY IN REPLYING, THAT IT WOULD GIVE MITTERRAND GREAT PLEASURE TO LUNCH WITH MRS THATCHER IN ROME ON SATURDAY 27 OCTOBER. IF POSSIBLE MITTERRAND WOULD PREFER THE LUNCH NOT TO START BEFORE 1315. ON ATTENDANCE : THE ASSUMPTION WAS THAT IT WOULD BE THE NORMAL FORMAT IE PRINCIPALS PLUS ONE, PLUS INTERPRETERS ONLY, WITHOUT AMBASSADORS. ON THE FRENCH SIDE, HENNEKINNE DID NOT RULE OUT THAT HE MIGHT GO TO ROME, BUT HE THOUGHT IT MOST LIKELY THAT THE PRESIDENT WOULD BE ACCOMPANIED BY CAROLINE DE MARGERIE, WHO HAS NOW ASSUMED ELISABETH GUIGOU'S EUROPEAN RESPONSIBILITIES AT THE ELYSEE (THOUGH SHE HAS NOT TAKEN OVER GUIGOU'S ROLE AT THE SGCI, NOR AS EASTERN EUROPEAN COORDINATOR).

3. HENNEKINNE FELT THE AGENDA WROTE ITSELF: DISCUSSIONS WOULD FOCUS ON EUROPE AND THE NEAR AND MIDDLE EAST.

Special European Council, Rome: 27-28 October

I enclose a list of our proposed delegation to the Special European Council in Rome on 27-28 October. We have exchanged letters separately about the support staff.

We expect the meeting in Rome to be similar in character to a normal European Council, with the Presidency producing draft Conclusions in the usual way. There will be two working sessions, and the dinner.

The agenda is a mixture of Community and political cooperation items. We expect the Political Committee to need to meet during the Council, hence the need for the Political Director to staff it. Michael Jay and John Kerr are the experts on the full range of Community subjects, including preparations for both IGCs, sites of EC institutions, and external EC issues including assistance to the Soviet Union. If Bernard Ingham would find it helpful, Brian Mower would go to help him as before. John de Fonblanque will perform his Antici Group role.

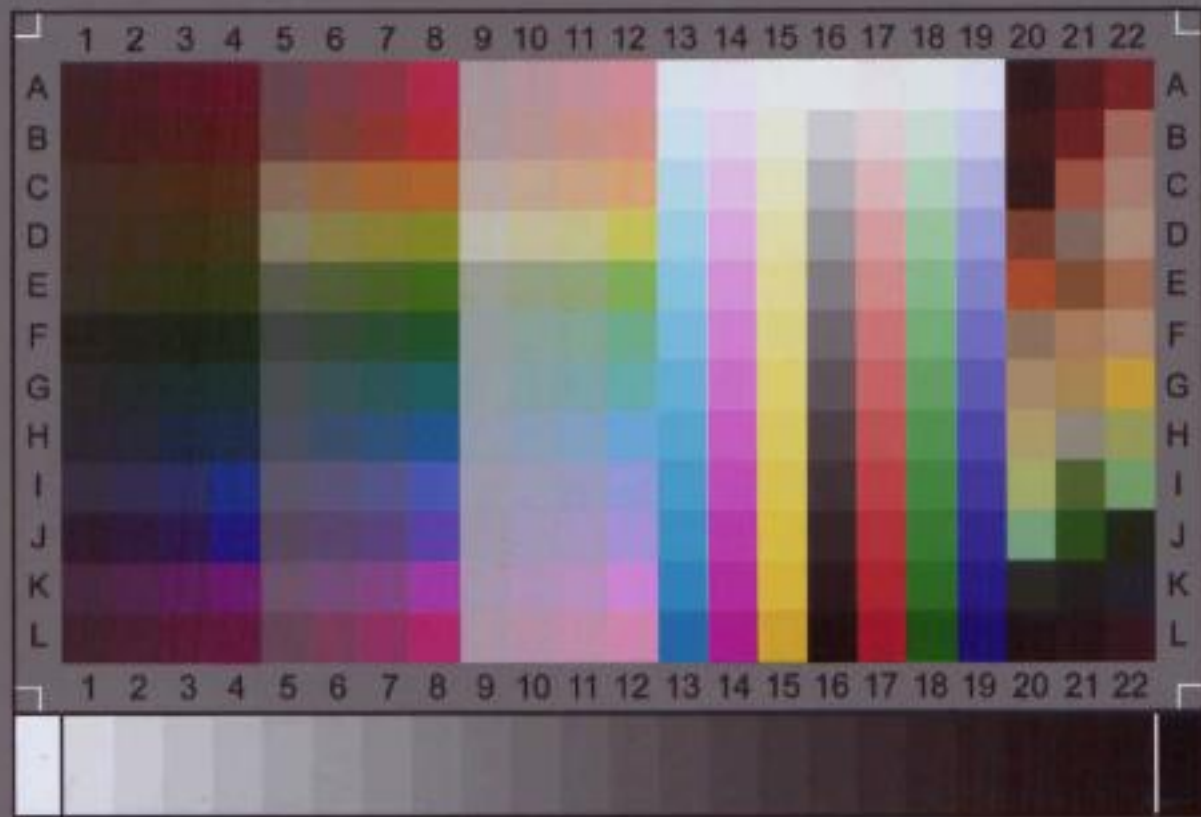
